**1. INTRODUCTION**

The Board of Directors (“**Board**”) of REVEZ Corporation Ltd. (“**Company**”) and together with its subsidiaries, the “**Group**”) refers to the announcement made by the Company on 1 July 2022, in relation to the entering into a Shares Transfer Agreement (“**STA**”) with Tan Keng Siong (“**Mr Tan**”, and together with the Company, the “**Parties**”), in relation to the Company’s disposal of all of the shares held in its 55% owned subsidiary, AIAC Pte. Ltd. (“**AIAC**”) (“**Sale Share**”) to Mr Tan for an aggregate cash consideration of S\$200,000 (the “**Consideration**”), on the terms and subject to the conditions of the STA (the “**Proposed Disposal**”).

All capitalised terms used and not defined herein shall have the same meanings given to them in the announcement dated 1 July 2022 in connection with the Proposed Disposal.

**2. COMPLETION OF THE PROPOSED ACQUISITION**

The board is pleased to announce that the transfer of shares to Mr Tan is executed and the Completion has taken place today. Following the Completion, AIAC has ceased to be a subsidiary of the Company.
