PROFIT GUIDANCE ON UNAUDITED FINANCIAL RESULTS FOR THE SIX MONTHS ENDED 30 JUNE 2023

The Board of Directors (the “**Board**”) of REVEZ Corporation Ltd. (the “**Company**”), and together with its subsidiaries (the “**Group**”) wishes to announce that following a preliminary review of the unaudited financial results for the six months ended 30 June 2023 (“**1H2023**”), the Group is expected to report a consolidated net loss for 1H2023.

The net loss was mainly due to decline in revenue generated from both the IT solutions and Digital Media Networks segments and higher expenses (i.e. legal and professional fees) incurred in relation to the diversification into healthcare business and acquisition of Magenta Wellness Pte Ltd.

Further details of the Group’s financial performance will be disclosed when the Company announces its unaudited financial results for 1H2023 by 14 August 2023.
